- New/Transfer Application – Specify permit type. If applying for “Beer, Wine, & Liquor Restaurant 210”, please write that.
- County Verification of Business Location, signed by County Surveyor (please include the FULL address at the top – street, suite # if applicable, city, state, zip code).
- Property Tax Clearance Schedule, signed by County Treasurer. If applying under an LLC, write the entity name at the top.
- A floorplan, signed and dated.

- If a corporation or LLC, a copy of the Certificate of Existence from the Secretary of State's office <https://bsd.sos.in.gov/publicbusinesssearch>
- A Consent to Transfer form, one from each individual owner to the new entity.
- A copy of the purchase agreement specifying the permit number and price. If no purchase agreement is available, an Affidavit of Purchase Price form.
- Proof of liquor liability insurance, see here for insurance requirements <https://www.in.gov/atc/files/ATC-Notice-Liquor-Liability-Insurance.pdf>
- \$250 transfer of ownership fee / \$250 for transfer of location / \$500 if both.
- \$2 fee for a public notice sign.
